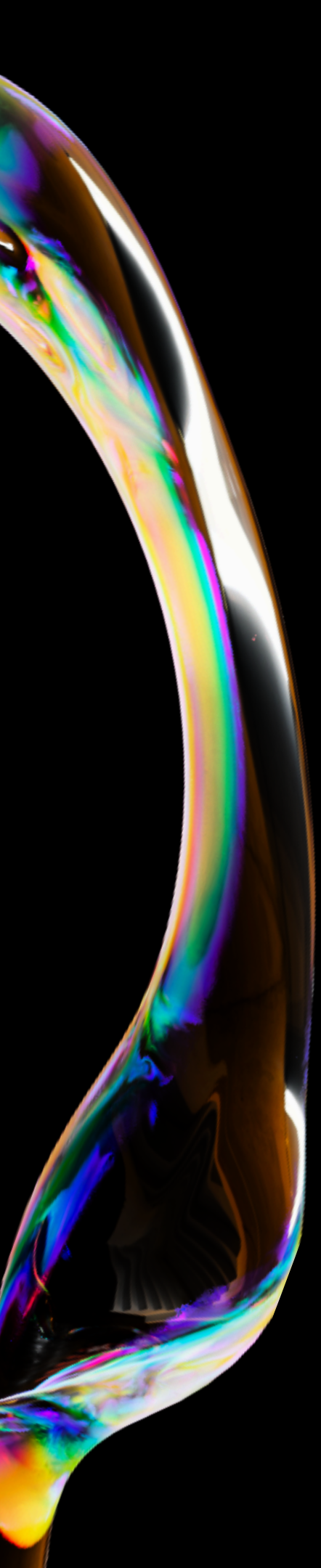

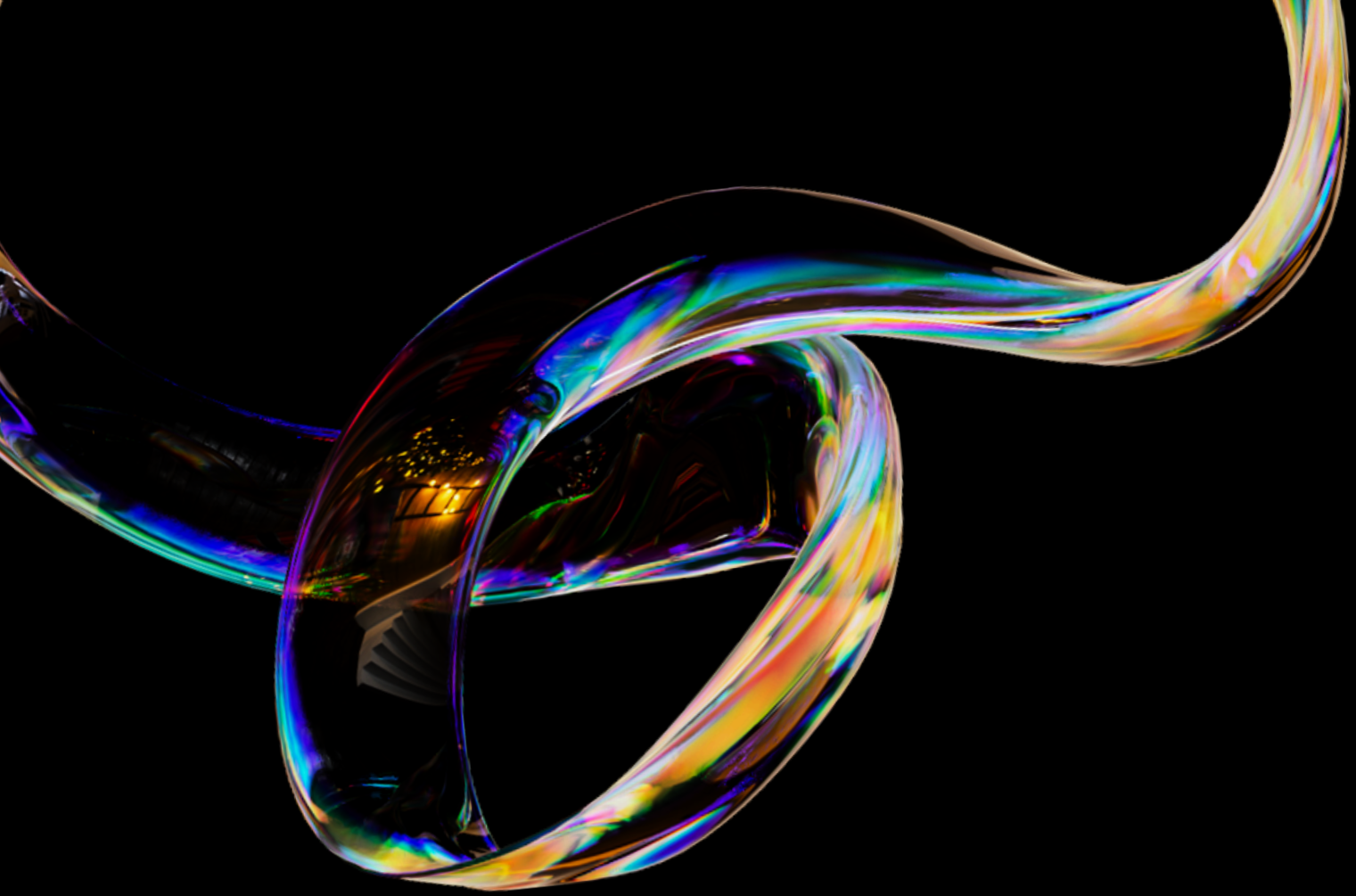
ABSTRACT

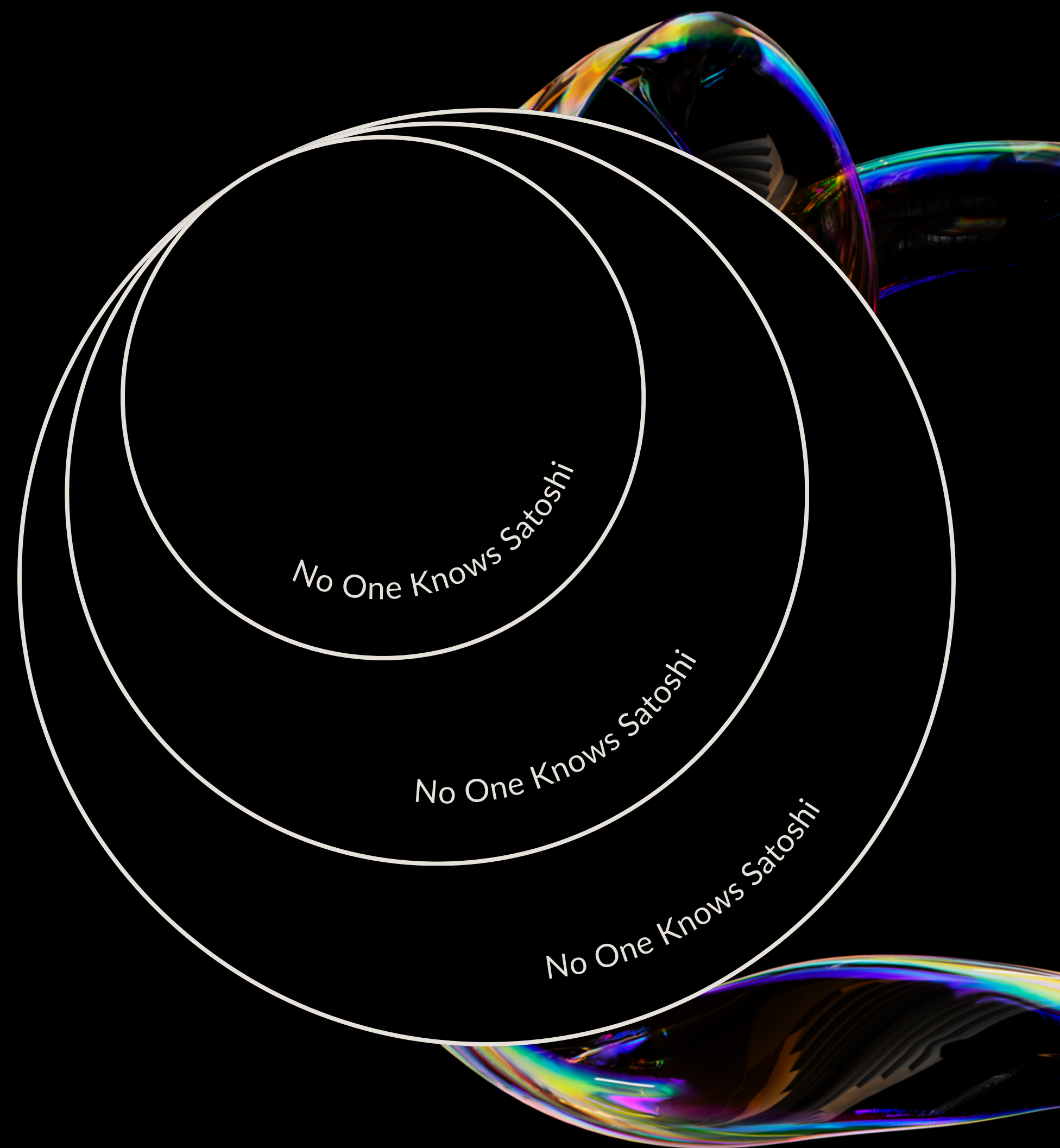
